## Total revision of the Insurance Contract Act; A Commission of Experts has been established

Bern, 13.02.03. The total revision of the Insurance Contract Act has been initiated. At the request of the Federal Office for Private Insurance (FOPI), Federal Councillor Ruth Metzler has established an academic commission of experts under the direction of Prof. Anton K. Schnyder, to develop an appropriate revision proposal by 2004.

The work of the academically oriented commission of experts will not only include addressing the longstanding political concerns that have not already been taken into account in the pending partial revision of the Insurance Contract Act. The commission will in particular also need to pay close attention to the development of insurance contract law in our neighbouring countries and in the rest of Europe, and to the delimitation of the law of social insurance.

The following experts are part of the commission:

Specific arrangements have been made to consult the ombudsperson for private insurance. The lobbies that are affected by the revision are included in this work within the framework of hearings.
