### Dr. Patrick Raaflaub, Director



Patrick Raaflaub (born 1965) studied political science, business and economics at the University of St Gallen, earning his doctorate in 1994.

Following periods with Credit Suisse and EBDI Consulting AG, Mr Raaflaub joined Swiss Re in 1994, where he remains to this day. He has held various positions with the company and has worked in Germany, Italy, the USA and Switzerland.
